- · Wearing a button-down shirt is suggested.
- · Bring any hair accessories or flowers you wish to use.
- Please arrive with clean, dry hair, and makeup free.

*An added fee may apply if a shampoo and/or blow-dry is necessary.

We offer complimentary tea, coffee, and water, but you are invited to bring in any
drinks or food that you feel will make your day more special. We can also arrange delivery of food and
beverages for an additional fee from a local restaurant.

*We offer the entire bridal party 10% off any additional services leading up to the wedding day.

DEPOSIT

A deposit of \$150 is needed to reserve wedding date along with a credit card on file. The \$150 is non-refundable. Due to the nature of the business, your wedding date will not be held until a deposit is paid, a credit card is on file, and a contract is received. Your deposit will be deducted from the wedding day balance. The final payment for all services will be due 2 weeks prior to the wedding date. We accept credit cards, cash, or check.

ADDITIONAL FEES

A 20% gratuity will be added to the final total.

OFF-SITE locations, an added fee of \$100 will be added for travel to anything beyond 10 miles of Salon Blu along with any added fees that may occur such as hotel or parking.

SERVICE/PARTY CHANGES + CANCELLATION POLICY

Any changes to the requested services or number of people in the party must be submitted 60 days before the wedding day. After that date, you will be responsible for the cost of all services listed in contract

Cancellations can be made up to 90 days before the wedding day without any extra charges. If you cancel 30 days prior to your wedding day 50% of the total wedding date rate quote will be charged to credit card provided. If you cancel 14 days or less of the wedding day you will then be charged 100% of the total wedding day rate quoted.
