TERMS AND CONDITIONS

1. Booking & Deposit

A non-refundable deposit of \$150 is required to secure the wedding date. This deposit will be applied toward the final balance. Dates are not held without a deposit.

2. Travel & Accommodations

Any travel time exceeding 1.5 hours one way will require the bride to provide hotel accommodations for the service provider(s) for the night prior to the wedding. An additional mandatory travel fee of \$100 will be charged for any services performed outside of Isabella County.

3. Cancellations

Cancellations made less than 30 days prior to the wedding date will forfeit the deposit and may incur additional fees depending on the services scheduled.

4. Trials

A bridal trial is strongly recommended and must be scheduled in advance. Trials are not included in the wedding day service total unless otherwise noted.

5. Gratuity

An automatic 20% gratuity will be added to the final total of all services rendered.

6. Payment

Final payment is due no later than 7 days prior to the wedding. No services will be rendered without full payment.

7. Bridal Party Discounts

All wedding party members will receive 10% off any additional services booked prior to the wedding and 20% off any retail purchases.

8. In-Salon Wedding Day Option

If the wedding party chooses to be scheduled in the salon for their services, they are welcome to bring in food and beverages to enjoy during their appointments.
